## **Citizen's Charter**

### **1. Introduction**

The Ministry of Electronics and Information Technology (MeitY), under Government of India, is a stand-alone ministerial agency, responsible for formulating and implementing national policies and programs aimed at enabling the continuous development of the electronics and IT industry. MeitY's focus areas include the development, promotion, and regulation of the electronics and IT industry in India, fostering digital governance, enabling innovation in emerging technologies and promoting cybersecurity initiatives within country.

### **2. Mission**

The mission is to promote Digital Governance for empowering citizens, promoting the inclusive and sustainable growth of the Electronics, IT & ITeS industries, enhancing India's role in Internet Governance, adopting a multipronged approach that includes development of human resources, promoting R&D and innovation, enhancing efficiency through digital services and ensuring a secure cyber space.

**3. Objectives:** The Ministry is dedicated to a multifaceted set of objectives, aligning with the dynamic landscape of technology and its impact on society:

1. e-Government: Providing e-infrastructure for delivery of e-services
2. e-Industry: Promotion of electronics hardware manufacturing and IT-ITeS industry
3. e-Innovation / R&D: Implementation of R&D Framework-Enabling creation of Innovation/ R&D Infrastructure
4. e-Learning: Providing support for development of e-Skills and Knowledge network
5. e-Security: Securing India's cyber space
6. e-Inclusion: Promoting the use of ICT for more inclusive growth
7. e-Diplomacy: Promoting the use of India Stack / DPI
8. Internet Governance: Enhancing India's role in Global Platforms of Internet Governance
